This is in continuation to the earlier Timeline issued vide Notification of even No. dated July 17, 2020, regarding the conduct of examinations for the students of Terminal Semesters/years and repeaters including backlog paper holders, in RGU and affiliated Colleges; that, RGU authority, while taking cognizance of the extension of the ongoing complete lockdown announced by the state government for the state capital region and Papum Pare district upto 3rd August, 2020, has decided to issue a **fresh reviewed Timelines** for students of terminal semesters/years as furnished below;

REVISED TIMELINE FOR TERMINAL SEMESTER AND REPEATER EXAMINATION INCLUDING BACKLOG PAPERS**

Sl. No.	Event	Date
1.	Last date of submission of internal assessment marks by the HoDs / Directors / Principals to CoE with the list of eligible candidates for terminal semester. Note: (a) Internal assessment marks of SBC papers may be submitted as per norms taking the average of best of two internal assessment tests. Practical/Assignment marks of SBC may be reflected separately. (b) This sub point has been dropped.	24 th July, 2020 (Friday)
2.	Filling up of examination form for the Terminal Semester students and Repeaters (year loss student), Repeaters of 2 nd and 4 th Semester of UG and 2 nd Semester of PG will have to appear the examination to clear their backlog semester only. Students of terminal semester (6 th semester of UG and 4 th semester of PG) having back papers in the even semester (2 nd and 4 th semester) will have to appear the same examination to clear their backlog papers.	25 th July 2020 (Saturday) to 10 th August, 2020 (Monday)
3.	Vacation of the university hostels by the intermediate semester students*	4 th August 2020 (Tuesday) to 7 th August, 2020 (Friday)
4.	Sanitization of hostel and make it ready for Quarantine of the students*	On or before 9 th August, 2020 (Sunday)
5.	Arrival of terminal semesters students and Repeaters from other state and containment zones of the state (for compulsory Institutional Quarantine/facility Centre of Govt. and swab testing)*	10 th August (Monday)

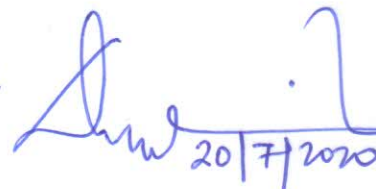

9.	Commencement of end semester examination for terminal semester students for University & Colleges <i>(including practical and backlog papers of the terminal semester students)</i>	:	7 th September, 2020 (Monday) – 28 th September, 2020 (Monday)
10.	Vacation of the university hostels by the terminal semester students*	:	29 th September, 2020 (Tuesday)
11.	Sanitization of the hostel and make it ready for students accommodation*	:	On or before 5 th October, 2020 (Monday)
12.	Publication of Result by the CoE office	:	24 th October, 2020 (Saturday)

* Applicable only for the university. Colleges will prepare their own guideline for movement of the students as per their convenience following the Government directives.
